IMPORTANT DATES:

Sept. 29: Deadline to receive entries and fees

Oct. 11: Notifications mailed

Nov. 6, 8:30-9:30 a.m.: Entry Day - hand-delivered, framed and ready to hang paintings due at Pauahi Tower

Nov. 12, 4:30-6:30 p.m.: Opening reception and award presentation

Dec. 11, 8:30-9:30 a.m.: Show take down. Pick up paintings at Pauahi Tower.

ELIGIBILITY: This exhibition is open to all artists of Hawaii.

ENTRIES AND FEES: \$10 per painting for members; \$20 per painting for non-members. Up to six entries per artist may be entered. ***Renew your membership (\$25 annual dues) before entering to avoid being charged the non-member entry fee.***

SPECIFICATIONS: All works must be in 80% or more soft pastel medium (includes NuPastels). No oil pastels will be accepted. All work must be original – conceived and created independently by the entrant within the last two years. Work that was previously accepted in ***any*** juried exhibition in Hawaii, done in a class or workshop, or copied from public material is not eligible. Acceptance of unusual entries shall be at the juror's discretion.

Framing & Matting: Mats and frames should be simple. If mats are used, they must be neatly cut, clean and in an off-white or light neutral (greyed) value. No otherwise colored mats will be allowed. A slim colored inner mat or fillet, no wider than 1/4", is acceptable. If no mat is used, frames must use a spacer to separate the painting from the glass or plexiglas. The frame, itself, must not be overly ornate or wide, give an impression similar to a colored mat or detract from the painting.

Frames must be undamaged and wired for hanging. No sawtooth hangers, nails, gallery clips or protruding screw eye hooks will be accepted. Image Perfect, Conservation and Museum glass or plexi-glass are acceptable (non-glare glass or non-glare plexi will not be accepted). Paintings delivered in a chipped, cracked, damaged, dirty or in an otherwise unprofessional presentation will not be accepted and will be returned at the artist's expense. Caution must be taken to insure that submitted paintings are not overly heavy. PAH is not responsible for any damage to any work hung during the course of the show.

SUBMISSIONS: ***All entries and fees must be received by PAH no later than Sept. 29, 2010.*** Digital images of your paintings can be submitted either online on the PAH Web site or by mailing in your images on a CD.

Digital Photo Format

Each image should be 1150 pixels in its largest dimension and no more than 1.8 MB in file size. Due to the online submission restrictions, larger files cannot be accepted. Determine your file size, by selecting the file and highlighting Get Info or View Properties in the main menu. **Each image file must be saved as a BASELINE JPG (not "standard" or "progressive").**

Online Submission

Go online to the PAH secure server site, <https://www.pahartists.net/>, and select "Enter the PAH Annual Juried Exhibition." Complete the Show Entrant Form for new entrants and submit the form. You will be asked to create a username and password. Once you have done so, you may enter your paintings with our online form. You should have the following information handy: 1) title of the painting, 2) painting dimensions (actual viewable image width and height in inches), 3) painting price, 4) the painting file in jpeg image format.

You may return to the site to upload your paintings at any time. Once submitted, you will not be able to change your entry, but you'll be able to view them. Your entries will remain in a pending status until your entry fees are received by PAH. Please note that you submitted your paintings online with your check. **Artists using online entry do not need to send in any of the forms with their fees and will be notified of acceptance via email.**

Submission by CD

If you mail a CD, you must name your files in this manner: Last Name - Title WidthxHeight.jpg.
Example: Smith-Fields of Green 24x18.jpg.

Mail your CD in a jewel case and padded envelope along with the completed entry forms, fees and a self-addressed stamped #10 (business) envelope to: PAH, c/o Candace Fenander, showchair, 46-214 Yacht Club St, Kaneohe HI 96744. **Entries and fees must be received no later than Sept. 29.** Artists may pick up their CDs on entry day. If you want your CD mailed to you, include a self-addressed stamped envelope for its return.

Acceptance Notification

Acceptance Notifications will be mailed out no later than Oct. 15. Please note, that this acceptance is an initial screening only. It is up to the juror, when he sees the actual painting, to determine whether or not the painting will be in the show. A catalog fee of \$5 per artist will be assessed upon acceptance and due on Entry Day.

SHOW ENTRY DAY: Saturday, Nov. 6, 8:30 - 9:30 a.m. Pauahi Tower Gallery, 1001 Bishop St.

Bring your accepted entries to the Mezzanine Gallery floor. The Pauahi Tower loading area is via Bishop Square parking on Alakea St.. Enter the parking structure, drive straight, past the guard station, down the ramp and turn left. Follow the lane as it veers right. When you come to a cross lane, turn right. The elevators will be on your left.

Your paintings will not be hung, without a liability waiver. A waiver will be provided for you to sign. Use the waiver form in this prospectus only if you are not the one dropping off your paintings. **Please be on time! Late entries will not be accepted once the judging starts.**

Same Day Pickup of Unaccepted Work: Saturday, Nov. 6, 12 noon - 1 p.m.

In the rare event that your painting is rejected at this stage, you will be notified by phone. Please be sure you can be contacted during this time and that you can return to Pauahi Tower before 2 p.m. to pick up your painting (building/parking structure closes at 2 p.m.).*

Artists Reception and Awards Presentation: Friday, Nov. 12, 4:30 - 6:30 p.m.

All participating artists are requested to bring a purchased ready to eat dish to the reception. The award presentation will begin at 6 p.m.

Show Takedown Day: Saturday, Dec. 11, 8:30 - 9:30 a.m.

All works **must** be picked up between 8:30 and 9:30 a.m. If you cannot make this pickup time, please make arrangements for someone else to pick up for you and let the show committee know who it will be.*

*** All paintings awaiting pick up will be left against the walls near the lounge tables in the gallery.**

Exhibition Hours:

The Mezzanine Gallery is open Monday through Friday from 7 a.m. to 7 p.m., and Saturdays from 7 a.m. to 2 p.m. The Mezzanine is closed on Sundays. Public parking is available at Ali'i Tower, entrance on Alakea Street.

Liability:

All possible care will be taken in handling and displaying each entry, however, neither Pastel Artists of Hawaii (PAH) or Pauahi Tower, or any other receiving agent will be responsible for any loss or damage to any work submitted for the exhibition. Each entrant must assume all responsibility for any loss or damage to any of their work and should carry their own insurance during the exhibition. To this end, all entrants are required to sign a liability waiver for their own entries. PAH is also not liable for paintings not picked up during the designated times. These paintings will be left at Pauahi Tower for pick up by the artist(s).

Entry Forms and Tags:

If entering by CD, **fill out the liability and notification forms, sign and mail them to PAH with your CD, entry fees and a stamped self-addressed envelope.** The "image size" is the viewable size or the mat window size (w x h) in inches. Fill out an Entry Tag for each accepted painting. Securely attach each tag to the backside, lower left-hand corner of its respective painting.
